

Website Terms of Use

1 Terms of Use

- 1.1 The website, located at www.mayfieldglobal.com.au (**Website**) is owned and operated by MayfieldGlobal Pty Ltd ACN 159 219 619 (**MayfieldGlobal**).
- 1.2 By displaying or using the Website, you agree to be bound by the terms and conditions set out below (**Terms of Use**).
- 1.3 In these Terms of Use, a reference to "we" or "us" is a reference to MayfieldGlobal.
- 1.4 A reference to "you" or "your" in these Terms of Use is a reference to any person accessing, viewing or using the Website.

2 Use of the Website

- 2.1 You may use the Website to view information and enquire about our services including, among other things, strategizing for your business in selling food and beverage products in the Asian market and navigating government regulations and product labelling requirements.
- 2.2 You may access the Website at any time, unless we have restricted access to perform necessary maintenance, updates or upgrades. Your ability to access the Website will otherwise depend on factors outside our control and we do not accept any responsibility for those factors such as the quality of your internet connection, the type of computer or mobile device used to access the Website and your software.

3 Limitations on Use

- 3.1 By accessing and using the Website you warrant and agree that you will:
- (a) not use the Website for any other purpose than provided under the Terms of Use;
 - (b) not use the Website for any commercial purpose without our prior written consent;
 - (c) not copy, transmit, distribute, reproduce, licence, alter, reverse engineer, adapt or modify the whole or any part of the Website in any way whatsoever;
 - (d) not hide, deface, alter or delete any copyright symbol, trade mark or other proprietary rights notice;
 - (e) not use the Website or any activity which is obscene, indecent, offensive or defamatory;
 - (f) not hack into, change or otherwise knowingly transmit a virus or otherwise damage the Website or any information contained within it;
 - (g) refrain from tampering with, hindering the operation of or making unauthorised modifications to the Website;
